THE BOARD RESPECTFULLY ASKS THAT COMMENTS REMAIN FOCUSED ON THE ISSUES BUT NOT SPECIFIC PERSONNEL, AS PERSONNEL IS HANDLED THROUGH OTHER AVENUES.

3 ATTEND & MAKE A
PUBLIC COMMENT

COMMENTS ARE LIMITED TO AGENDA ITEMS. ANY DISTRICT RESIDENT OR PARENT OF AN ENROLLED STUDENT HAVING A LEGITIMATE INTEREST IN AN AGENDA ITEM MAY PARTICIPATE. ATTENDEES MUST REGISTER THEIR INTENTION TO SPEAK UPON THEIR ARRIVAL AT THE MEETING. PARTICIPANTS ARE TO PREFACE THEIR COMMENTS BY ANNOUNCING THEIR NAME AND ADDRESS AND GROUP AFFILIATION, WHEN APPROPRIATE. COMMENTS ARE LIMITED TO THREE MINUTES UNLESS EXTENDED BY THE BOARD PRESIDENT, AND NO PARTICIPANT MAY SPEAK MORE THAN ONCE ON THE SAME TOPIC. COMMENTS ARE TO BE DIRECTED TO THE BOARD; NO PERSON MAY ADDRESS OR QUESTION BOARD MEMBERS INDIVIDUALLY.
